# **Housing Contract Release Guidelines**

Please note that if a student checks into a space, they are always responsible for the total amount of lived on nights and some additional fees may be added as listed below.

Student Teaching/ Internship for Academic Credit/ Study Aboard	*Email confirmation from Academic Advisor to University Housing Office *Housing Release Form Submitted
Medical	*Email confirmation from the Assistant Dean of Student Development or designee *Housing Release Form Submitted

### <u>Discontinuing Student - Contract Cancellation</u>

# Academic Interference - Contract Cancellation

Reason for Cancellation	Documents/ Confirmation Needed
Living with <i>Parents</i> in Broward, Dade or Palm Beach County	*Copy of student's driver's license, parent's driver's license, and utility bill/ lease, all with matching addresses within the tri-county area *Housing Release Form Submitted
Living with Guardian in Broward, Dade or Palm Beach County	*Copy of student's driver's license, <i>guardian's</i> driver's license, and utility bill/ lease, all with <i>matching</i> addresses within the tri-county area *Housing Release Form Submitted
Married or Domestic Partner	*Copy of marriage or domestic partnership certificate *Housing Release Form Submitted
You are a Veteran or in US Military Service	*Copy of military ID or similar proof *Housing Release Form Submitted
Age 25+	*University Housing Office will confirm this with University Records *Housing Release Form Submitted
49+ Credits	*University Housing Office will confirm this with University Records *Housing Release Form Submitted

#### \*Buyout Fee\*

 $\underline{(Additional\ Cancel\ Fee\ for\ Students\ who\ do\ an\ Academic\ Interference\ Cancellation})}$ 

If a student breaks their contract prior to the completion of the contract term dates, but remains a registered student at the university, that student will be responsible for a contract buyout and all the associated fees. Exceptions may only be made at the discretion of the Director University Housing, or their designees. Student staff may not approve a buyout exception.

Buyout Fee Detailed	occurs after the 10th week, 100% of the room rate is kept.
